SINGLE-PHASE RATES

STANDARD *Single-Phase Service* -- *Applicable to all single-phase services.*

Customer Charge	\$36.00 per month
Energy Charge (Summer).....	14.150 cents per kWh
Energy Charge (Winter) 1 st 750 kWh's.....	13.400 cents per kWh
Energy Charge (Winter) Next 750 kWh's.....	13.150 cents per kWh
Energy Charge (Winter) Next 1500 kWh's.....	12.900 cents per kWh
Energy Charge (Winter) Excess kWh's.....	12.650 cents per kWh

OPTIONAL *Single-Phase Total Electric Service* -- *Applicable to single-phase services where the consumer permanently installs and uses electric water heating and space heating equipment as the major source of heating.*

Customer Charge	\$36.00 per month
Energy Charge (Summer).....	14.150 cents per kWh
Energy Charge (Winter) 1 st 750 kWh's.....	13.400 cents per kWh
Energy Charge (Winter) Next 750 kWh's.....	12.650 cents per kWh
Energy Charge (Winter) Excess kWh's.....	11.570 cents per kWh

Note:

* These rates are subject to a Power Cost Adjustment (PCA) tariff. The PCA will vary from month to month depending upon the difference between the cooperative's actual cost of the energy component in the cost of purchased wholesale power and the base cost of the energy component in the cost of purchased wholesale power. The base cost of the purchased wholesale power energy component established in these rates is \$0.08036 / kWh.

Summer rates apply to usage from June 1 thru September 30

Winter rates apply to usage from October 1 thru May 31

OPTIONAL *Single-phase Earth-Coupled Heat Pump Service* -- *Applicable to single-phase services where the consumer permanently installs and uses an electric water heater and earth-coupled heat pump as the major source of heating.*

Customer Charge.....	\$36.00 per month
Energy Charge (Summer)All kWh's.....	13.150 cents per kWh
Energy Charge (Winter) 600 kWh's/ton.....	10.550 cents per kWh
Energy Charge (Winter) Excess kWh's.....	12.650 cents per kWh

OPTIONAL *Single-Phase Time-of-Use Service* -- *Applicable to single- phase services. May benefit those consumers who can shift the majority of their electricity consumption outside of the peak period. The **peak period is from 3:00 P.M. to 6:00 P.M. during the four summer months of June, July, August and September.** All other times are considered the off-peak period. The customer will be responsible for a portion of the associated metering costs up to a maximum of \$150.00 or a lesser amount if applicable.*

Customer Charge.....	\$36.00 per month
Energy Charge (Summer) Peak kWh's.....	30.000 cents per kWh
Energy Charge (Summer) Off-Peak kWh's.....	11.750 cents per kWh
Energy Charge (Winter) Off-Peak kWh's.....	11.750 cents per kWh

OPTIONAL *General Service Demand* -- *Applicable to single- phase services where the consumer contracts for a demand of not less than 20 kW or more than 100 kW. May benefit those customers with a high load factor.*

Customer Charge.....	\$48.00 per month
Demand Charge.....	\$14.00
Energy Charge (Summer).....	09.177 cents per kWh
Energy Charge (Winter).....	09.177 cents per kWh

Note:

* These rates are subject to a Power Cost Adjustment (PCA) tariff. The PCA will vary from month to month depending upon the difference between the cooperative's actual cost of the energy component in the cost of purchased wholesale power and the base cost of the energy component in the cost of purchased wholesale power.
