## THREE-PHASE RATES

**STANDARD *Three-Phase Service*** -- *Applicable to all three-phase services.*

Customer Charge.....	\$48.00 per month
Energy Charge (Summer).....	14.311 cents per kWh
Energy Charge (Winter) 1 <sup>st</sup> 2000 kWh's.....	13.561 cents per kWh
Energy Charge (Winter) Next 3000 kWh's.....	13.311 cents per kWh
Energy Charge (Winter) Excess kWh's.....	13.061 cents per kWh

**OPTIONAL *Three-Phase Time-of-Use Service*** -- *Applicable to three-phase services.*

*May benefit those consumers who can shift the majority of their electricity consumption outside of the peak period. The peak period is from 3:00 P.M. to 6:00 P.M. during the summer months of July and August. All other times are considered the off-peak period. The customer will be responsible for a portion of the associated metering costs up to a maximum of \$300.00.*

Customer Charge.....	\$48.00 per month
Energy Charge (Summer) Peak kWh's.....	75.000 cents per kWh
Energy Charge (Summer) Off-Peak kWh's.....	11.311 cents per kWh
Energy Charge (Winter) Off-Peak kWh's.....	11.311 cents per kWh

**Note:**

\* These rates are subject to a Power Cost Adjustment (PCA) tariff. The PCA will vary from month to month depending upon the difference between the cooperative's actual cost of the energy component in the cost of purchased wholesale power and the base cost of the energy component in the cost of purchased wholesale power. The base cost of the purchased wholesale power energy component established in these rates is \$0.08036 / kWh.

**Summer rates apply to usage from June 1 thru September 30**

**Winter rates apply to usage from October 1 thru May 31**

**OPTIONAL *General Service Demand*** -- *Applicable to two and three- phase services where the consumer contracts for a demand of not less than 20 kW or more than 100 kW. May benefit those customers with a high load factor.*

Customer Charge.....	\$48.00 per month
Demand Charge .....	\$14.00
Energy Charge (Summer) .....	.09.177 cents per kWh
Energy Charge (Winter).....	.09.177 cents per kWh

**OPTIONAL *Demand Load Management Service*** -- *Applicable to electric services where the consumer contracts for a demand of not less than 20 kW or more than 100 kW. May benefit those customers who agree to control their load in the Summer months of July and August during the peak hours of 3:00 P.M. to 6:00 P.M. upon being notified by the Cooperative. The customer will receive a credit of \$14.00 per shaved kW off of the monthly peak for these months and an energy credit of \$0.0080 per kWh each month for controlling at least 90% of their peak load.*

Customer Charge.....	\$48.00 per month
Demand Charge .....	\$14.00
Load Management Demand Credit.....	(\$14.00)
Energy Charge.....	.09.177 cents per kWh
Load Management Energy Credit.....	(.00.0080 cents per kWh)

**Note:**

\* These rates are subject to a Power Cost Adjustment (PCA) tariff. The PCA will vary from month to month depending upon the difference between the cooperative's actual cost of the energy component in the cost of purchased wholesale power and the base cost of the energy component in the cost of purchased wholesale power. The base cost of the purchased wholesale power energy component established in these rates is \$0.08036 / kWh.

**Summer rates apply to usage from June 1 thru September 30**

**Winter rates apply to usage from October 1 thru May 31**
