2021 Annual Meeting Canceled

Bluestem Electric Cooperative's 2021 annual meeting, which was scheduled for March 2021, has been canceled. The Bluestem trustees, at their October board meeting, made the difficult decision to cancel the meeting due to the uncertainty of the ongoing coronavirus pandemic. The annual report of Bluestem Electric will be published in the March edition of *Kansas Country Living* magazine.

Bluestem Administrative Offices to Consolidate to **Realize Savings and Gain Efficiencies**

Field Staff/Line Crew to continue operating out of Clay Center

At its Oct. 19 meeting, the Bluestem Electric Cooperative Board of Trustees approved a plan to consolidate the co-op's Clay Center administrative office with its Wamego office effective Feb. 1, 2021. This office and staff consolidation will improve office operation efficiencies and create a projected savings for the member-owned electric co-op of around \$900,000 over a 10-year period, by having the entire office operations team under one roof and eliminating duplicate facility expenses.

Every decision made at Bluestem is mission-focused to better serve the members. Bluestem's Mission Statement: It shall be the mission of Bluestem Electric Cooperative to provide safe and reliable electric energy and other services to our consumers as efficiently and economically as possible. Bluestem trustees and management staff want to be able to look members in the eyes and tell them what is being done to maintain stable rates and hold costs down while continuing to provide safe and reliable service.

The Bluestem line crew based in Clay Center will continue to work from the current Clay Center warehouse located at 610 Pomeroy. Having a warehouse for the field staff, trucks and equipment in the Clay Center area allows for optimum response times for Bluestem members located in Districts 1 and 2 of the 11-county area Bluestem serves.

In continuing our commitment to the Clay Center

community, the co-op hopes to build or relocate to a larger warehouse within the Clay Center area in the near future. Bluestem will also continue its membership in the Clay Center Chamber of Commerce and Clay County Economic Development Group, continue to offer community safety training events, participate in business expos and continue to support the local students with scholarships and other academic awards.

Cooperative Principle No. 7 is Concern for Community, so while Bluestem Electric Cooperative focuses on its mission of providing safe and reliable electric energy to our consumers as efficiently and economically as possible, we're also interested in the sustainable development of all communities throughout our 11-county service territory, and this will never change.

Bluestem staff realizes the office consolidation may alter the routine of some Bluestem members who are accustomed to paying their bill in person. Bluestem offers several ways to pay your bill and a Bluestem staff member will gladly help you find the most convenient method, whether it be by mail, online, automatic bank draft or by phone.

Bluestem Offers 10 SCHOLARSHIPS

Co-op Trustee Candidate Nominees

District 1. Position 2 BRUCE MEYER, Palmer

He said he is running for the board because he was asked to represent the area and will be a voice regarding cost, employment, equipment needs, safety, service and future goals.

District 4, Position 1 AMANDA GNADT, Alma

Gnadt lives just east of Alma with her husband, Alex, and their son, Adler. She works part-time for Kansas State University and assists Alex with their limestone quarry and farming activities. She is running because, "electricity is crucial to keeping farms and rural businesses running and I want to support those businesses and the families who choose to live rural. On the board, I will support initiatives ensuring dependable, quality service to Bluestem customers."

ERIC PECK. Manhattan

Peck lives in the Zeandale area and is a retired military officer who has a farm, helps his neighbors farm and volunteers as a firefighter and an instructor for the Service member Agricultural Vocational Education non-profit. He said he would like to keep Bluestem service reliable and reasonably priced and is also interested because of his previous experience with the Kansas National Guard and Kansas Division of Emergency Management on disaster response and mitigation.
