EXCERPT FROM THE BLUESTEM ELECTRIC BYLAWS

Bluestem Nomination and Election Process

SECTION 4.05 NOMINATION OF

TRUSTEES. The Board shall appoint a nominating committee, on or before the first of October of each year, consisting of not less than one, nor more than five members from each district for whom a Trustee is to be elected. Board members may not serve on the nominating committee.

Only committee members from each district will nominate their own candidate. Committee members from districts one and two will meet together in any County within District #1 and/or District #2 where the Cooperative is providing a Cooperative Service and committee members from districts three and four will meet together in any County within District #3 and/or District #4 where the Cooperative is providing a Cooperative Service. Nominating committees shall meet during the month of October. On or before the first day of November, the nominating committee shall prepare and post a list of nominations for Trustee at the Wamego office and on the Cooperative Website and/or other Cooperative Social Media sites. The committee shall nominate one or more candidates for each position. Nominations may be made by petition, filed on or before the close of business, November 30, at the Wamego office. The petition must be signed by no less than 5% of the membership of the

district for whom the Trustee is to be elected. The secretary shall immediately post such nominations at the same place where the list of nominations by the committee is posted. Nominations made by the petition shall appear on the ballot in the order received.

SECTION 4.06 ELECTION OF

TRUSTEES. The election of Trustees shall be by mail ballot and/or electronic ballot as determined by the Trustees. Only those nominees selected by the nominating committee or nominated by petition shall appear on the ballot. There may be write-in votes for a qualified member not named on the ballot. The ballot shall first list the name(s) nominated by the committee, then the name(s) nominated by petition in the order received and, at the end, a place to write in a name. Failure of strict compliance with provisions of this section shall not affect the validity of any election of Trustees.

The secretary shall mail the ballots to the respective members by the 10th day of December of each year.

On or before the first day of January of each year, ballots must be postmarked or received at the Wamego office.

Those members who have been appointed to serve on each district's respective Nominating Committee will be listed in next month's Kansas Country Living Magazine.




ENERGY EFFICIENCY TIP OF THE MONTH

School buses are among the safest vehicles on the road — but the greatest risk comes when children are getting on or off the bus. Whether you're a driver, parent or student, knowing these safety tips will help keep everyone safe.

FOR DRIVERS

- **SLOW DOWN:** Reduce speed in school zones and near bus stops.
- **KEEP YOUR DISTANCE:** Stay back at least 10 feet from a school bus — this is the most dangerous area for children.
- **STAY ALERT:** Watch for kids who may unexpectedly enter the road, especially near bus stops.
- **RESPECT THE ZONE:** When flashers are blinking in a school zone, stop for pedestrians at crosswalks and take extra care to look for children near playgrounds, parks and residential areas.

KNOW THE SIGNALS:

- YELLOW FLASHING LIGHTS: Bus is preparing to stop. Slow down.
- RED FLASHING LIGHTS AND STOP **ARM:** Bus is loading/unloading — stop and wait until the bus moves again.
- **NEVER PASS A STOPPED BUS ON** AN UNDIVIDED ROAD: It's illegal in most states.

FOR PARENTS

Teach your child to arrive at the bus stop at least 5 minutes early, and how to play it **SAFE**:

- ► Stay back at least 10 feet, or five giant steps, from the curb.
- ► Always wait for the bus to stop and the driver to signal before boarding.
- ► Face forward and buckle up if seat belts are available.
- Exit carefully, look both ways and cross in front of the bus — never behind. Make eye contact with the driver before crossing.

SAFETY TIP

Keep plants and fences away from green transformer boxes — especially the padlocked side. Utility crews need at least 10 feet in front and 4 feet

on the sides to work safely and quickly during outages. Keep a clear path to the transformer — even if it's in your yard. It's technically on an easement, and they still need access!



TIPS TO AVOID UTILITY SCAMS

Delete deceptive emails. If you receive an email that appears to be from your electric utility but you are unsure about it, delete it. Never click on a link, open an attachment or send a reply to an untrusted source. When in doubt, contact your utility directly to report suspected email scams.
